01. Changes in the amount of Eurasian fees

EAPO REVISES FEES

ECONOMIC CHANGES

Certain fees in the Eurasian Patent Organization will be amended as of February 1, 2025. Due to inflation and exchange rate volatility, certain fees for Eurasian applications and patents for inventions have been indexed, including fees for filing applications, conducting examinations, amending and modifying documents, filing appeals, extending missed time limits, restoring rights, etc. The unitary procedural fee will amount to 60,000 rubles. Find out more about the new fees in the "Statute on Fees." Applicants from the EAPO Member States are granted reduced tariffs: state universities and educational organizations shall pay 30% of the total amount of fees; natural persons shall pay 10% of the total amount of fees. Legal entities receive a 10% discount when paying fees... Read more

The EA-PPH program has been drafted in order to establish a common information and examination space in accordance with the EAPO Development Program for 2023-2028 and to provide an effective tool for cooperation between... INPI EXTENDS PPH PILOT PROGRAM WITH CHINA UNTIL NEW AGREEMENT FOR 2025-2029 In a letter to the China National Intellectual Property Administration (CNIPA), the INPI announced the extension of the Patent Prosecution Highway (PPH) pilot program with the Asian country, which would end on December 31, 2024. The agreement not only aims at economic integration through the removal of trade barriers but also promotes cooperation in key areas such as the environment, human rights, and the protection of intellectual property. In the latter area, the agreement establishes a framework to improve the mutual recognition of rights, the protection of geographical indications, and the promotion of innovation, which are key elements to achieve fairer and more competitive trade between the two regions.

09. Hague System - Israel modifies its individual designation fees

NEW FEE STRUCTURE
FOR DESIGNATING
ISRAEL IN THE HAGUE
SYSTEM AND REDUCED
FEE ELIGIBILITY

The Government of Israel has announced modifications to its individual designation fees under the Hague System. These changes will take effect on March 24, 2025.

When designating the Israel in an international application, the individual designation fees will be adjusted as follows:

- 114 Swiss francs (default fee) and 68 Swiss francs (reduced fee) for each design included in an international application;
- First renewal: 142 Swiss francs for each design;
- Second renewal: 170 Swiss francs for each design;
- Third renewal: 199 Swiss francs for each design;
- Fourth renewal: 227 Swiss francs for each design... Read more

To provide more diverse and flexible examination options for design patent applications, TIPO launched the "Accelerated Examination Pilot Program for Design Patents" on September 1, 2023. Initially set to run until December 31, 2024, the program has now been extended through December 31, 2026. A further evaluation will determine whether to continue or modify the program.

The details of the program are as follows:

1. Application Timing: Applicants may file for accelerated examination for design patents after receiving TIPO's notification that the preliminary examination is about to begin and before receiving the first Office Action. 2. Application Process: Applicants must file electronically in accordance with TIPO's regulations... Read more

The Danish Patent and Trademark Office has made a price adjustment of publication and renewal fees for patents, including validated European patents. The fees have increased by approximately 3.0 percent. The adjustment is valid from 1 January 2025. The Danish Patent and Trademark Office also made a price adjustment on 1 January 2024. Please find an overview of the fees before 1 January 2025 and the fees after 1 January 2025 in the table below. The prices are in DKK.

The price adjustment of the renewal fees is valid for fees due after 31 March 2025. This means that the renewal fees due up until 31 March 2025 will be payable at the rates applicable before... Read more

The Japan Patent Office (JPO) and the National Institute of Industrial Property of France (INPI) have been implementing the PPH pilot program since January 1, 2021. The pilot program has been extended for an additional five years starting from January 1, 2025. The new pilot period is scheduled to end on December 31, 2029, but it may be extended if necessary. Please note that a PCT application cannot directly enter the national phase at the INPI. For certain types of applications eligible for PCT-PPH at the INPI based on a PCT international work product by the JPOplease refer to Figures A to C in ANNEX II to the Guidelines for filing with the INPI available on the following page... The eligibility criteria have been expanded from startups established for less than eight years to also include companies with innovative R&D capabilities that have received national awards within the past two years and companies guided by organizations commissioned by TIPO. 17. Hague System – Reduction in the Individual Designation Fees for the Republic of Moldova

From March 1, 2025, there will be a reduction in the individual designation fees applicable when designating the Republic of Moldova under the Hague System.
